## Brokersumo Payment Gateway

BrokerSumo has officially Sunsetting the old payment processor and it's full steam ahead with the **New BrokerSumo Processor - eCommission Payment Gateway!** Please

make sure to set this up if you do leases, referrals, or expect any sales checks to be sent to the office.

Because there are optional faster processing choices at a cost to the agent (will deduct on that transaction's CDA), a new checkbox was added on the transaction to be paid by direct deposit. This must be checked off BEFORE generating the CDA to work as intended. Please check off for all leases, referrals, and new builds that will only mail a check to the Brokerage (and if you know the check was mailed to us or funds are in escrow).

Selling Agent Info

Check off BEFORE the CDA is generated for Rentals, Referrals, and any Sales where the check is mailed to the office. This must be checked off before CDA creation to allow for direct deposit payment.

## REMINDERS

→ Texas Ally requires **AT LEAST 5 BUSINESS DAYS** to review a CDA but no longer than 2 weeks out from closing. Please keep in mind that creating the disbursement **DOES NOT** autosend approval request.

→ If you're not taking commission on a deal you still **need to submit** your request and get an approved CDA.

→ Office mail is picked up and checks are deposited into the Texas Ally escrow account only **on Wednesdays**.

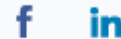
→ **Friday Payday** is when we distribute commissions by initiating the Brokersumo Direct Deposit as long as ALL requirements have been met.
